## MITIGATING THE HOUSING CRISIS' IMPACT ON CHILDREN AND FAMILIES

The economic well being of children is directly linked to that of their parents, and most recently this housing crisis has brought to light the quiet suffering taking place in communities across America. Over 2 million home mortgage foreclosures were initiated in 2008, and in the first quarter of 2009, almost 800,000 more were filed. By 2012, conservative estimates anticipate over 8 million foreclosures. Research has shown that children who lose their homes are more likely to move from school to school, proven to be associated with poor educational outcomes and behavioral problems. Likewise, poor health outcomes for children are also associated with financial stresses. In 2008, NHCSL partnered with the Annie E. Casey Foundation to launch a housing initiative that was received with great enthusiasm by our legislators at the NHCSL National Summit in November in Las Vegas.

At our Summit, we explored in detail the specific outcomes associated with home loss and identified ways that legislators can assist their constituents in preventing foreclosures. We also learned about resources available to assist with fair lending practices and education on the topic of foreclosures. But the 3-hour symposium left many with more questions and more ideas. We are pleased that in 2009, the Casey Foundation will continue this much needed work with a second round of funding that will explore legislative best practices that emerged as a result of our work in 2008, as well as new policy strategies in the arena of economic well being for children and families.

The most successful policy strategies will simultaneously promote opportunities for parents and opportunities for children as it will promote stability within the home. So what can policymakers do? Although federal policy governs many of the transactions involved in home foreclosures, state policy plays an important role as well. A number of states are pursuing strategies that are considered promising by experts in the field, including required mediation in foreclosures, a moratorium on foreclosures, protections against predatory mortgage lending, and counseling and financial assistance.

Using federal and state funds, policy-makers can pursue multiple financing strategies, including connecting residents to federal sources of aid, pursuing no-cost legal protections, and assessing the return on investments in preventing foreclosures. As NHCSL members continue to enact promising policies, we are all paying close attention to implementation and accountability to ensure that the desired results are achieved for children and families. ## IMMIGRATION REFORM GAINS MOMENTUM: BRINGING PEOPLE TOGETHER

Earlier this summer, a national campaign to pass comprehensive immigration reform was launched. A week-long series of activities showed a huge national support for comprehensive immigration. A coalition of labor unions, business leaders, civil rights and religious groups, and pro-immigrant advocacy organizations announced the Reform Immigration FOR America Campaign, to focus their collective political power and also provide the American public a way to communicate their support for comprehensive immigration reform directly to lawmakers in DC.

Polls consistently show that at least 60% of the American people support comprehensive immigration reform. Likewise, it grows increasingly clear that rounding up and deporting 12,000,000+ undocumented residents is not a feasible political reality. Furthermore, the campaign is deploying new technologies such as a national text messaging system and various on-line organizing strategies to direct messages from constituents directly to Members of Congress. This, combined with a national campaign staff of organizers and policy experts, increases the chances for legislative success in 2009.

In Georgia, State Representative Pedro “Pete” Marin actively participated in this week of awareness. Rep. Marin described immigration policy today as “one based on fear, ignorance and hate. The lack of compassion and the total disregard for basic human rights is deplorable and cannot be tolerated anymore in Georgia. We blame immigrants for everything, yet everyday exploit their labor for our own personal gain... Now is the time to say BASTA! The soul of our state is in jeopardy of being irreparably broken. Our policies are destroying families, uprooting communities and destabilizing economies. This is not the way civil society should treat individuals whose only crime is trying to find an honorable way to feed, clothe, and house those they love. Fortunately, change is in the air.”

"Our work is focused on putting forth the economic value of immigrants to this country and the detriment to future growth without comprehensive reform. The Obama administration recognizes the commitment made to reform and the importance that it has to the Latino community," said Representative Ben Miranda.

This launch marks the beginning of a historic campaign to achieve immigration reform which is intended to make sure the American Dream is alive for all children and families. Nationally, more than 200 organizations have signed onto the campaign and more than 700 participants participated during the week-long event. ## NHCSL'S HEALTH CARE INITIATIVE MAKING STRIDES

In addition to the work that has begun with the White House to ensure input from our members on the Administration's Health Care Reform agenda, NHCSL continues to work aggressively on specific health care issues. Most recently, NHCSL co-hosted a Health Disparities Conference with NBCSL; funding for this conference was provided by Novartis. An emphasis was placed on vaccines and their roles in public health safety. As H1N1 elevates to a pandemic designation, this conference is timelier now more than ever.

Over the course of 2 days, NHCSL members heard from vaccine policy experts from throughout the nation to address the importance of vaccines in adolescents and the elderly. While there are significant private and public systems in place to ensure childhood vaccinations, the same does not hold true for adolescents and the elderly in the Hispanic and African American communities. NHCSL legislators discussed the ways that they can work in their individual states to begin addressing these inadequacies. As such, working to message directly to this population has become critical.

While health care costs are an impediment to many seeking medical services, many of these vaccines are made available to the public at limited or no cost. This is an awareness issue that needs to reach our constituents. Working with local health departments, medical institutions, and strategic partners such as Novartis, awareness and education can be addressed by NHCSL legislators. Many deaths can be avoided with preventive measures that are available and affordable.

With the more overarching discussion of health care reform at the front burner for Congress, NHCSL continues to advocate for legislation that will ensure greater access and equity for our community. We are watching closely at what emerges from Congress. The Joint Committee on Taxation has estimated that implementing a tax on employer-provided benefits could generate \$418.5 billion over ten years, partially offsetting the estimated \$1.2 trillion cost of health care reform. The Congressional Budget Office (CBO) has yet to release cost estimates on other provisions of the plans, a challenging task due to the varying provisions among the major proposals being discussed. Finally, few states have addressed government provided or assisted health care options which could serve as models as Congress moves forward with reform. We will continue to update members on the progress of health care reform in Congress, to determine their impact on individual states. ☺
